2018-20 Term Position Openings

There are five positions on the Board of Directors open for election in June 2018. These are Four Member-at-Large positions and one President-Elect position.

Application Deadline

Wednesday, February 28, 2018 by 11:59 p.m. EST.

ALL REQUIRED INFORMATION MUST BE SUBMITTED BY THE DEALINE IN ORDER FOR THE CANDIDATE TO BE ELIGIBLE TO BE CERTIFIED.

However, note that should the number of eligible candidates filing for a position be the <u>same</u> <u>or less</u> than the number of seats open for the position then the filing deadline is automatically extended to <u>Friday</u>, <u>March 30</u>, 2018. And, further, however, should the number of eligible candidates filing for a position be <u>less</u> than the number of seats open for the position then the filing deadline is automatically extended to <u>Sunday</u>, <u>April 29</u>, 2018.

Filing Declaration Submission Instructions

The Filing Declaration form along with additional supporting information should be submitted to Headquarters by Wednesday, February 28, by 11:59 p.m. EST via email to (<u>noblemen@sigtau.org</u>). Please note that the Filing Declaration has two sections that require separate pages attached. One is the Background Information and it is REQUIRED. The other is the Candidate Questions and it is REQUIRED.

PLEASE USE the most up to date version of the FILING DECLARATION, updated Jan. 17, 2018.

The initial meeting of the new Board of Directors will be held on the morning of July 1, so please do not plan to depart sooner than that afternoon.
