

## **COVID-19 Protocol**

Auburn University

If a member becomes ill...

- Call the [Medical Clinic](#) for a phone screening (334-844-4416)
- Notify WPN Staff ([noblemen@sigttau.org](mailto:noblemen@sigttau.org) or 317-644-1920)
- Ill-Member Isolation Plan
  - While in the facility, the member would be required to remain in his bedroom at all times aside from using a designated restroom. No other common spaces would be permitted to be used by the member.
  - Member may be asked to return to a primary residence when possible.
  - Member may be asked to temporarily relocate within the chapter house to be determined by WPN staff as a safety precaution.
    - Their individual bedroom suite (if single occupancy) would be the designated isolation space.
    - If the member is in a double occupancy room or with a shared bathroom space, Rooms 101 or 102 would be designated as the isolation space within the house.
  - Member would be required to utilize the restroom facility located within his bedroom suite.
  - Member would be required to enter/exit the property only at a specific point of entry.
  - Meals would be provided via a “late plate” delivery to the doorstep of the member.
  - Member would be removed from all of their chapter house duties.
  - Member must receive approval from a medical provider that he can resume regular house use.
- Chapter Member Safety Plan
  - All other members would be required to maintain social distance, as defined by CDC guidelines, and are not permitted to have physical interactions with the ill member including indirect physical interactions such as entering the isolated space or touching commonly shared surfaces.
  - Other members may be asked to temporarily relocate within the chapter house by WPN staff as a safety precaution.
    - Their bedroom suite (if single occupancy) would be the designated isolation space.
    - If the member is in a double occupancy room or with a shared bathroom space, Rooms 101 or 102 would be designated as the isolation space within the house.
  - Foodservice would be presented in “to-go” containers with no buffet service.
  - Additional cleaning and disinfecting practices would be implemented, based on CDC guidelines, for the duration of the member’s isolation.

- Amended chapter house rules would go into effect including no guests or out-of-house members permitted at the house, no alcohol of any kind permitted, and gathering size restrictions based on current CDC guidelines.
- Chapter leaders would be encouraged to adapt chapter operations during member isolation as a safety precaution.

If the university mandates closed housing...

- WPN will provide communication regarding the house closure, health safety precautions individuals must take, temporary move-out instructions, etc. in conjunction with directives from Auburn University Greek Life office.
- WPN staff will work with vendors to address any changes in service needed.
- Any presence at the chapter house while the house is closed by any member or non-member who has not been approved by WPN staff to be there, would be considered trespassing.
- The chapter would be issued a cease and desist order from WPN staff for all operations of the chapter property.
