Proposed LAWS Amendment 5 – Amendments to the method of determining the amount of initiation fees and dues and fees paid by members and collegiate chapters.

The Undergraduate Operations Committee hereby recommends that the following amendments be made to the Laws of the Fraternity (deletions in strike through; additions underlined):

To amend LAW V as follows:

SECTION 1. Initiation Fee: Every initiate into this Fraternity shall pay a membership fee before his initiation. The House of Delegates shall set, by resolution, the amount, and structure of the membership fee. ***[Recording Secretary Comment: As presented for consideration, the previous sentence was suggested to be deleted; however, by action of the Grand Chapter, it was not.]***

~~SECTION 2. Payment of Fees: Each collegiate chapter shall pay the Fraternity the membership fee for each collegiate member initiated by that chapter into the Fraternity.~~

~~SECTION 3. Local Fees: Collegiate members shall pay chapter dues to support their chapter program. Chapter dues shall be set by the chapters.~~

SECTION ~~5~~3. Payment of Fees: Each collegiate chapter shall pay the Fraternity the membership fee for each collegiate member initiated by that chapter into the Fraternity. Payment of membership fees must be made within the time limits, procedures and conditions set by the policy of the Headquarters of the Fraternity. ~~Thereby, each initiate shall receive a membership manual, a badge, a membership card, a membership certificate, and a life subscription to The SAGA of Sigma Tau Gamma.~~

SECTION ~~6~~4. Collegiate Chapter Fee Increase: Upon evaluation and approval by the Board of Directors the Fraternity may increase undergraduate membership fees and dues and chapter fees no more than 2% each academic year.

Further, to amend LAW VII, Section 4 as follows:

SECTION 4. Payment of Fees and Dues: Each collegiate chapter shall pay into the General Fund of the Fraternity, semester fees and dues to be set by the Board of Directors. ~~House of Delegates resolution~~ and each collegiate

chapter shall remit promptly to Headquarters the dues and fees which are prescribed by the Constitution and Laws.

Further, to amend LAW VII, Section 7 as follows:

SECTION 7. National Fees: Each collegiate chapter shall pay into the General Fund of the Fraternity, such other dues and fees to be set by House of Delegates resolution.

Further, to amend LAW VII, Section 8 as follows:

SECTION 8. Convention Fee: Each collegiate chapter shall pay a semi-annual fee set by ~~the Board of Directors resolution of the House of Delegates to the Fraternity~~, to be set-aside in a convention fund. Said convention fund shall be used to offset a portion of the costs of holding the annual meetings of the Fraternity, including the House of Delegates.

Proposed Resolution 2 – Elimination of the use of Hard Alcohol during Fraternity Events or within Fraternity facilities

The Constitution, Laws, and Resolutions Committee hereby recommends that the following Resolution be adopted by the Fraternity:

WHEREAS in Sigma Tau Gamma, true fraternalism is nurtured in an atmosphere of social and moral responsibility, respect for duly constituted authority, and loyalty to the Principles of the Fraternity; and,

WHEREAS the excessive and/or unsupervised use of hard alcohol poses a risk to the health and welfare of collegiate members of the Fraternity and their guests; therefore, be it,

RESOLVED that as of September 1, 2019, hard alcohol is prohibited from any and all Chapter events and facilities, unless served by a licensed third-party vendor; and further,

RESOLVED that “hard alcohol” be defined as an alcoholic beverage with an alcohol by volume (“ABV”) above 15% (30 proof).

Proposed LAWS Amendment 7 – Amendments to the deadlines and method of submission of the declaration of candidacy for the Board of Directors

The Constitution, Laws, and Resolutions Committee hereby recommends that the following amendments be made to the Laws of the Fraternity (deletions in strike through; additions underlined):

To amend LAW XI, Section 3 as follows:

SECTION 3. Candidate Filing: Candidates for offices on the Board of Directors of the Fraternity shall file for office with the Chief Executive Officer on or before ~~(120 days)~~the 15th day of March in the year of the House of Delegates biennial meeting, or the next regular business day if that day falls on a weekend or holiday. ~~and~~ Candidates shall be certified as eligible to hold office by the Chairman of the Election Commission to qualify for candidacy. Candidates shall file for office using the Candidate Filing Declaration form provided by the Election Commission, and this Candidate Filing Declaration must be received by the filing deadline for the candidate to be certified as eligible. The filing Declaration shall be submitted electronically to the electronic mail address designated by the Chief Executive Officer. However, should the number of eligible candidates filing for a position be the same or less than the number of seats open for the position then the filing deadline shall be extended (30) days ~~in the year of the House of Delegates.~~ And, further, however, should the number of eligible candidates filing for a position be less than the number of seats open for the position ~~(60) days before the deadline, then the filing after the second extended deadline, then the filing deadline~~ shall be extended ~~to~~ 10 business days before the published opening date of the House of Delegates. An eligible candidate is defined as a member in good standing with the Fraternity who has completed orientation on the Fraternity's Governance Policies as approved by the Board of Directors.

Proposed LAWS Amendment 4 – Technical and Corrective Amendments

The Constitution, Laws, and Resolutions Committee hereby recommends that the following technical amendments be made to the Laws of the Fraternity to correct grammatical, typographical, and syntax errors, and to correct terms no longer used by the Fraternity (deletions in strike through; additions underlined):

- a. To amend LAW I as follows:

SECTION 1. Collegiate Chapter Role: ~~The structure of the e~~Collegiate chapters shall be organized for the successful accomplishment of the purposes of the Fraternity among collegiate members.

SECTION 2. Alumni Members Role: Alumni members of the Fraternity shall share an active role in the direction and guidance of the collegiate chapters.

SECTION 3. ~~Purpose of~~ Alumni Chapter Role: ~~The structure of the a~~Alumni chapters shall be organized primarily for the successful accomplishment of the purposes of the Fraternity among the alumni members of the Fraternity.

- b. To amend LAW II, Section 4 by replacing the word “Laws” with the words “Constitution, Laws, and policies of the Fraternity”.

- c. To amend the first sentence of LAW VI, Section 5 to replace the words “A Associate chapter” with “An Associate Chapter”.

- d. To amend LAW VII, Section 9 by replacing the words “Executive Board Structure” with the words “Executive Cabinet Structure”.

- e. To amend LAW VII, Section 11 by replacing the words “Purpose of Property” with “Purchase of Property”.

f. To amend LAW VIII, Section 8, paragraph C to replace the word "Council" with the word "Team" where ever it appears.

g. To amend LAW VIII, Section 8, paragraph G as follows:

G. Members of a Chapter Advisory Team shall not serve concurrently ~~as~~ on the Board of Directors₂ or as officers of or on the board of any chapter-based affiliate organizations.

h. To replace the word "Colony" with the words "Associate Chapter" where ever it appears in the LAWS.

i. To Amend LAW VIII Sections 4 and 5 as follows:

SECTION 4. Alumni Association ~~Grand Conclave~~ Delegates: Each recognized chapter Alumni Association shall be entitled to appoint and send one delegate and one alternate delegate to represent itself ~~at the Grand Conclave~~ in the House of Delegates at its or its member's own expense. A member in good standing of an Alumni Association may be seated as the delegate or alternate for the Alumni Association if the appointed delegate or alternate delegate fails to attend the ~~Grand Conclave~~ House of Delegates. Although the delegate and alternate delegate may attend, the Alumni Association shall be permitted only one vote.

SECTION 5. Alumni Association Voting Rights: Recognized Alumni Associations shall be entitled to the same voting privileges other than on issues of undergraduate fees and dues as chapters in good standing at the House of Delegates ~~Grand Conclave~~, Annual Meetings, or on matters submitted for approval by mail vote of the Fraternity.

j. To amend LAW IX, Section 1 to replace the word "Corp" with the word "Corporation" and to replace the word "Corps" with the word "Corporations".

k. To amend the LAWS to replace the words "Regional Vice President" with "Regional Director" where ever it appears.

l. To amend LAW XIV, Section 6 to replace the words "collegiate, alumni member" with "collegiate or alumni member".

- m. To amend the LAWS to replace the words “Board Board” with the word “Board” where ever it appears.
- n. To amend LAW XV to change the title of that law from “DISCIPLINE: COLLEGIATE CHAPTER, AND ALUMNI ASSOCIATION” to “DISCIPLINE: COLLEGIATE CHAPTER, ALUMNI CHAPTER, AND ALUMNI ASSOCIATION”
- o. To amend LAW XV, Section 4 as follows by deleting the phrase “The penalties that may be levied by a Standards Board regarding discipline under this Law include:” following the word “Penalties:”
- p. To amend LAW XV, Section 4, paragraph a, subparagraphs iii, iv, and v by adding the word “Association,” after the word “Chapter,”.
- q. To amend LAW XV, Section 4, paragraph a, subparagraph vi by adding the words “or Alumni Association recognition” after the words “Chapter Charter”.
- r. To amend LAW XV, Section 4, paragraph c by deleting the words “or stop”
- s. To amend LAW XVI, Section 4, to add the word “a” before the word “vest” and the word “collared” before the word “shirt”
- t. To amend LAW XVI, Section 3 to replace the words “Extra Ordinary” with the word “Extraordinary” the first time it appears.

Proposed Constitutional Amendment 2 – Amendments to Article XII, Section 3

The Constitution, Laws, and Resolutions Committee hereby recommends that the following amendments be made to Article XII, Section 3 of the Constitution of the Fraternity (deletions in strike through; additions underlined):

SECTION 3. Disposition of chapter and affiliate group assets.

- A. Fraternity Property: Should a ~~Chapter~~ chapter or its affiliate alumni group become inactive or have its Charter and/or recognition suspended or revoked, ~~the Charter, records, archives, ritual equipment and paraphernalia shall become the property of the Fraternity~~ all Fraternity property shall be returned to the Headquarters office, including but not limited to the Charter and all ritual equipment and paraphernalia.

- B. Assignment of Obligations: If a chapter owes money to the Fraternity at the time it becomes inactive or has its charter and/or recognition revoked, upon election of the Chief Executive Officer, any obligations owed to the chapter by its undergraduate and alumni members shall be deemed to have been assigned to the Fraternity, and Headquarters shall have the right to collect any of said obligations due and owing to the chapter apply said funds to the debt due and owing to the Fraternity. ~~All outstanding debt of the chapter at the time it becomes inactive or has its charter revoked shall become the joint and civil liability of the undergraduate members of the chapter at the time the debt was incurred.~~

- C. Personal Property: Future Recognition: Should a chapter or its affiliate alumni group become inactive or have its charter and/or recognition suspended or revoked, any and all obligations and fines due and owing the Fraternity from the Chapter or affiliated alumni group shall be immediately paid to Headquarters from any funds held by the Chapter or its affiliated alumni group, and a failure to do so may constitute grounds for denial of recognition by the Fraternity in the future.
 - 1. ~~Should a chapter or affiliate group become inactive or have its Charter suspended or revoked, its non-real property assets of less than ten thousand dollars (\$10,000) shall become the property of Sigma Tau Gamma Fraternity Inc. and will be absorbed into its general fund.~~

D. Management of Remaining Assets: After the payment of all debts due and owing the Fraternity, any remaining funds or other liquid assets belonging to a chapter or affiliate group that has become inactive or had its charter and/or recognition revoked or suspended may be deposited with the Headquarters, who will manage and hold said funds according to an agreement reached between the Headquarters and representatives of the affected group who have not been expelled by the Fraternity.

~~Should a chapter or affiliate group become inactive or have its Charter suspended or revoked, its non-real property assets of more than ten thousand dollars (\$10,000) shall be held in trust for a period of eight years by Sigma Tau Gamma Fraternity Inc. During this time, interest earned on the funds held in trust will accrue to the trust, less a reasonable management fee which will accrue to the Fraternity on a yearly basis. In the event said chapter or affiliate group remains inactive or non-chartered after the eight-year period, then the non-real property assets shall be absorbed into the Fraternity's general fund.~~

E. Real property: The Fraternity may condition the recognition of any alumni association or housing corporation, and the benefits afforded thereby, upon the adoption of certain provisions in the entity's governing documents that protect the continuity of housing at the host institution.

~~1. Should a chapter or affiliate group become inactive or have its Charter suspended or revoked, all real property owned by said chapter or affiliate group shall be transferred to the Sigma Tau Gamma Fraternity, Inc. to be managed in the best interest of Sigma Tau Gamma.~~

~~2. Sigma Tau Gamma Fraternity Inc. shall have (90) days from dissolution to disclaim its rights granted under this section. In the event, it does not disclaim its right then said property shall be transferred as applicable by law.~~

Note:

Some of the provisions contained in this recently added Article of the Constitution were deemed to be not legally proper or enforceable by the Fraternity's counsel. The proposed amendments do not raise the same legal concerns.

SECTION 6. Notification for Initiation: No Chapter shall initiate any person until Fraternity Headquarters has been notified of the initiation date and location, the application for membership has been completed, and the associate and initiation fee are paid in full.

Proposed Constitutional Amendment 1 – Technical and Corrective Amendments

The Constitution, Laws, and Resolutions Committee hereby recommends that the following technical amendments be made to the Constitution of the Fraternity to correct grammatical, typographical, and syntax errors, and to correct terms no longer used by the Fraternity (deletions in strike through; additions underlined):

- a. To amend Article III Section 1 paragraph C to place the word “the” before the words “Chief Executive Officer.”
- b. To amend the word “Rituals” to the word “Ritual” as appropriate where ever it appears.
- c. To amend Article V Section 1 as follows:

SECTION 1. ~~The supreme legislative authority of the Fraternity is the House of Delegates, for the good of the Fraternity, and to adopt and amend the Constitution and Laws of the Fraternity.~~
Authority to legislate for the good of the Fraternity, and to adopt and amend the Constitution and Laws of the Fraternity, shall be vested in the House of Delegates.

- d. To amend Article VII Section 2 as follows:

SECTION 2. Composition of Regions: Each Region shall have administrative officers appointed by the Chief Executive Officer who shall be alumni ~~or honorary~~ members of the Fraternity.

- e. To amend the second sentence of Article VIII Section 8 as follows:

The opening and closing ~~of~~ chapter meetings Ritual is considered esoteric and any changes thereto also requires the approval of the House of Delegates.

- f. To amend Article IX Section 6 to substitute “e.g.” for “i.e.” in the last sentence thereof.
- g. To amend the first two paragraphs of Article XI Section 1 as follows:

Relationship Defined: Sigma Tau Gamma Fraternity is a non-profit corporation. It is incorporated under the laws of the State of Missouri. ~~It is headquartered in Warrensburg, Missouri.~~

Sigma Tau Gamma Fraternity ~~as a non-profit corporation~~ is formed for the purposes of fostering fraternity and as an educational and service resource for collegiate chapters of Sigma Tau Gamma Fraternity, and for persons associated with those chapters.

Notes:

1. When speaking of the belief system of the Fraternity, it is appropriate to refer to it as the Ritual. When referring to individual ceremonies, those events could alternatively be referred to as ceremonies or rituals.
2. Article V Section 1 does not make sense grammatically in its current form, most likely due to a prior error in updating the Constitution. The proposed amended language is identical to the most recent version that did grammatically make sense, substituting the words “House of Delegates” for the words “Grand Chapter.”
3. The Fraternity has eliminated honorary membership.
4. The term i.e. is an abbreviation for the Latin words *id est* which translates to “that is” or “in other words. The term e.g. is an abbreviation for the Latin words *exempli gratia* which translates to “for example.”
5. Headquarters is no longer located in Warrensburg, Missouri. Alternatively, instead of deleting the location altogether, it could be corrected to “Indianapolis, Indiana.”

Proposed LAWS Amendment 10 – Amendments to the method of determining the amount of dues and fees paid by alumni associations and alumni chapters, and the operation of Alumni Chapters.

The Alumni/Volunteer Operations Committee hereby recommends that the following amendments be made to the Laws of the Fraternity (deletions in strike through; additions underlined):

To amend LAW V as follows:

~~SECTION 32.~~ Alumni Association Fees: Alumni members may support the alumni program through a system of dues or fees. shall pay alumni association dues to support their alumni association. Alumni Association dues shall be set by the association.

~~SECTION 6.~~ Alumni Tokens of Membership: Each alumnus member of a local fraternity or Associate chapter which is installed as a collegiate chapter of this Fraternity, who is certified in good standing and eligible according to ARTICLE 3 of the Constitution, may be initiated as a member upon payment of a fee set by resolution of the House of Delegates and shall receive a membership card, a membership certificate and a life subscription to The SAGA of Sigma Tau Gamma.

~~SECTION 65.~~ Alumni Association Fee Increase: Upon evaluation and approval by the Board of Directors the Fraternity may increase or decrease alumni association fees and dues no more than 2% each academic year.

~~SECTION 6.~~ Alumni Chapter Fees: Each Alumni Chapter shall pay into the General Fund of the Fraternity fees and dues to be set by the Board of Directors.

Further, to amend LAW VIII by adding a new Section 9 as follows:

~~SECTION 9.~~ Alumni Chapters: Policies regarding the organization and recognition of Alumni Chapters may be adopted by the Board of Directors.

Note:

Section 6 is proposed to be deleted because of a proposed amendment pending before the Undergraduate Operations Committee – which would not make any distinction between

undergraduate initiates and alumni initiates (all would be treated the same). The Committee may consider conditioning recommending this proposal contingent on the proposal to treat all initiates the same being adopted.

Such Constitutions and Bylaws shall be subject to the ~~approval~~ review of the Chief Executive Officer, who may deny recognition of a group should its governing documents conflict with the Constitution, Laws, or policies of the Fraternity. Chapter Advisory Teams shall not maintain independent constitutions or bylaws.

To amend LAW X, Section 2 as follows:

SECTION 2.
