I also served as a Representative of Student Government in 1986 and 1987 and was on the Homecoming and Curriculum Development Committee.

#### Alumni:

I was named State Director for Eastern Pennsylvania in 1989 and served in that capacity for several years. During my tenure in that position, I regularly visited the Chapters that I was responsible for and reported to the District Governor and Regional Director. I was involved with the Regional Director in planning regional meetings and presenting at those meetings a variety of topics for member development. I attended other Regional Meetings. I also attended 6 Chapter Charter celebrations.
